Summary:

This project was accepted as complete by County Parks on August 3, 2007 by Sansone Company, 710 Fiero Lane, Suite 21, San Luis Obispo, CA 93401. The project consisted of the installation of a new prefabricated comfort station within Waller Park, Santa Maria. The new building is compliant with current ADA regulations and includes new handicapped accessible concrete sidewalks, new plumbing and electrical connections.

This project is within the approved Fiscal Year 2007- 08 Capital Improvement Program.

Background:

This new comfort station is located in Waller Park within walking distance of the existing W.O.O.F. Park (unleashed dog park) and adjacent group picnic facilities. This area of the park previously had no restroom facilities.
