Background

- **Passed by Voters in June 1990**
 - **Voters Approved a special tax to fund enhanced services at the Goleta Library.**
 - **In accordance with the terms of ballot Measure L that authorized the special tax:**
 - **Board must hold public hearing to annually fix the amount of tax to be collected.**
 - **Tax can be adjusted each year based on changes in CPI.**
