To the Honorable Members of the Board of Supervisors:

In your consideration of the request to overturn the Planning Commission's denial of Mr. Nesbit's request for the right to land a helicopter on his estate in Summerland, please consider the precedent setting nature of your decision.

If you permit this use of helicopters in or near residential neighborhoods you are opening the door to what will become a flood of applications over the coming years that expect the same treatment. You may well be creating a precedent that leads to the approval of a dozen other applicants - much to the detriment of our community.

In this case, the public interest for peaceful and quiet neighborhoods far outweighs the narrow personal benefit to one individual in our community. Mr. Nesbit is well within his rights to make his request - and you are well within yours to reject it in the public interest.
