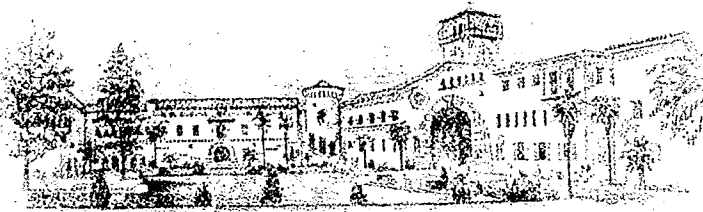

## RESOLUTION OF COMMENDATION FOR KELLY BULL SUPERVISING PROBATION OFFICER FOR 25 YEARS OF DEDICATED SERVICE TO THE CITIZENS AND COUNTY OF SANTA BARBARA

WHEREAS, Kelly Bull was born in Palo Alto, CA and raised in San Martin, CA. Kelly relocated to Santa Barbara County, where in 1994 she began working for the Santa Barbara County Probation Department. Kelly graduated from California Polytechnic State University, San Luis Obispo in 1999, with a graduate certificate in business and accounting. She also graduated from American Intercontinental University in 2002, earning a Bachelor of Arts degree in Criminal Justice, and a Master's Degree in Education in 2005; and

WHEREAS, she was initially assigned to the Santa Maria Court Services Unit as a Probation Assistant, and rose through the ranks ultimately being promoted to Supervising Probation Officer in 2012. Additionally, Officer Bull worked as an Extra Help Juvenile Institutions Officer from 2000-2012; and

WHEREAS, during her tenure with the Santa Barbara County Probation Department, Officer Bull worked with numerous youth and adults, many of which have benefitted from her passion of effecting change. Additionally, she mentored and trained many officers positively impacting their professional development; and

WHEREAS, Officer Bull received several accolades during her career, receiving the Women in Criminal Justice award by the Lompoc Penitentiary and California Department of Correction and Rehabilitation, Juvenile Deputy Probation Officer of the Year in 2005, Supervising Probation Officer of the year in 2014, and the Santa Maria Elks Public Safety Awards in 2009 and 2012; and

WHEREAS, Officer Bull is looking forward to spending time with her husband Brian, her three children Kristina, Derrick, Brian, and granddaughter Tyler.
