- VI. Provision 4 entitled, <u>Amounts Payable</u> of Exhibit B entitled, "Budget Detail and Payment Provisions", is amended to read:
  - 4. Amounts Payable
    - A. The amounts payable under this Agreement shall not exceed:
      - 1) \$2,291,000 for the budget period of October 1, 2005 through September 30, 2006.
      - 2) \$2,497,190 the budget period of October 1, 2006 through September 30, 2007.
      - 3) \$2,497,190 \$2,576,000 for the budget period of October 1, 2007 through September 30, 2008.
    - B. Reimbursement shall be made for allowable expenses up to the amount annually encumbered commensurate with the state fiscal year in which services are performed and/or goods are received.
    - C. The Contractor must maintain records reflecting actual expenditures for each state fiscal year covered by the term of this Agreement.
- VII. All other terms and conditions shall remain the same.
