SUBJECT: No Parking Zone on Calle Real. Second Supervisorial District.

### **RECOMMENDATIONS:**

C.A. Recommendation:

That the Board of Supervisors adopt a resolution establishing a "No Parking" zone on Calle Real in the Goleta area.

### ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

### **EXECUTIVE SUMMARY & DISCUSSION:**

Calle Real is a major east-west arterial in the Goleta Valley. The segment of Calle Real that is the topic of this resolution starts at San Marcos Road and extends westward 1,510 feet to its first terminus. This segment of Calle Real is 42-feet wide with non-fronting residences along its north side, and a tall freeway sound-wall along its south side.

A request was received from the manager of San Antonio Village located on the north side of Calle Real for no overnight parking on the north side of Calle Real from San Marcos Road to the westerly terminus. The public is parking motor homes, travel trailers, cargo trailers, and boats on the north side of Calle Real. The owners of these vehicles are causing a nuisance to the residents by tossing debris over the fences of adjacent residences. The California Highway Patrol has been unsuccessful in enforcing the county parking limits. To create a safer and healthier environment, the Public Works Traffic Section has been asked to prepare the attached resolution establishing a No Parking zone at the following location:

- A. On the north side of Calle Real from a point 140 feet west of the centerline of San Marcos Road to a point 885 feet west of the centerline of San Marcos Road.
- B. On the north side of Calle Real from a point 140 feet west of the centerline

of San Marcos Road to a point 885 feet west of the centerline of San Marcos Road.

C. On the north side of Calle Real from a point 1,427 feet west of the centerline of San Marcos Road to a point 1,462 feet west of the centerline of San Marcos Road.
