Summary:

This item is on the agenda for the Board of Supervisors' consideration pursuant to procedures outlined in Section V, Term of Office, in the Board-adopted General Plan Advisory Committee (GPAC) Guidelines of April 9, 1991 (Attachment 2). The nine-member MCPAC was established by the Board of Supervisors by resolution on November 21, 2006 to work with staff to draft Residential Design Guidelines and an update to the 1984 Mission Canyon Area Specific Plan. The nine-member MCPAC term of office was extended by the Board of Supervisors by resolution on November 4, 2008. Since then, one MCPAC member resigned in June 2009. The vacancy was posted and applications accepted in accordance with the GPAC Guidelines. In order to complete the policy update and provide guidance on

a residential parking strategy for the community, it is recommended that the Board of Supervisors appoint a new member to continue the MCPAC as a nine-member committee.

Background:

As directed by the Board of Supervisors, the MCPAC is conducting a collaborative public process to update land use policies for the community of Mission Canyon. The policy update began in December 2006 and the MCPAC's work on this project will be completed in approximately Spring 2010. In addition, a new project to develop a Residential Parking Strategy for Mission Canyon was approved by the Board for funding in the Office of Long Range Planning's 2008 – 2009 Work Program. The MCPAC's continued input and advisory role is needed for this project, projected to finish in 2010.
