Recommended Actions:

That the Board of Supervisors:

- a) Approve and authorize the Chair to execute a Real Property Agreement with Oscar Peters, Trustee of Oscar Peters Trust Dated April 9, 2012 (Attachment A), both for the acquisition of permanent easements over APNs 155-020-037 and 155-020-038 in exchange for a portion of APN 155-020-015 in connection with the Toro Canyon Oil Water Separator;
- b) Accept the Easement Deed from Oscar Peters for APNs 155-020-037 and 155-020-038 (Attachment B); and authorize the Clerk of the Board to execute the Certificate of Acceptance;
- c) Authorize the Chair to execute a Grant Deed to Oscar Peters, Trustee of Oscar Peters Trust Dated April 9, 2012, over a portion of APN 155-020-015, while reserving a permanent non-exclusive easement therefrom not required for County use, pursuant to Government Code section 25365 (Attachment C);
- d) Authorize the Public Works Director, or their designee, to execute any supporting documents to complete this transaction; and

e) Find that pursuant to the California Environmental Quality Act Guidelines Section 15378(b)(5) the proposed actions do not constitute a "Project," in that they are government administrative activities that will not result in direct or indirect changes in the environment.

Summary Text:

This item is on the agenda in order to acquire easements needed for the County to provide oversight of the Toro Canyon Oil Water Separator system. The County is currently fee owner of APN 155-020-015, a 40-foot-wide landlocked parcel between two parcels owned by the Oscar Peters Trust (APNs 155-020-037 and 155-020-038). In exchange for granting a portion of the County's fee interest to this landowner while reserving a permanent non-exclusive easement, the County will obtain two new permanent easements over portions of APN 155-020-037 and APN 155-020-038. These two actions will provide the County the necessary access for the construction, oversight, and maintenance of the Toro Canyon Oil Water Separator System.

In summary, the recommended actions include approval and authority to execute a Real Property Agreement, accept an Easement Deed, execute the Certificate of Acceptance for the easement, and execute the Grant Deed.

Background:

In 1882 Occidental Mining and Petroleum Corporation began construction on a horizontal tunnel at the site of a well-known oil seep in Toro Canyon. Such wells were commonly used to enhance oil flow. During construction, a large volume of water was inadvertently tapped. Further development of the oil resource was abandoned for the important water supply that was needed for the growing community of Summerland.

As Summerland switched to other water supplies, the onsite separator fell into disrepair and numerous spills occurred into the creek. Significant spills in the 1990s resulted in oil flow to the ocean. Initially the California Department of Fish and Wildlife (CDFW) then Fish and Game responded. By 1997 a Unified Command was established with the U.S. Environmental Protection Agency (EPA) and CDFW serving jointly as Incident Commanders.

In 1998, the Toro Canyon Oil Water Separator was subsequently installed under direction of the EPA. It was operated by EPA until December of 2008; the County of Santa Barbara has provided oversight of the Toro Canyon Oil Water Separator since January 2009.

The Toro Canyon Oil Water Separator system includes three primary components: 1) an oil / water separator, 2) a pipeline, and 3) an oil containment tank. These systems were constructed on and within several private properties. One of those properties is a narrow, land-locked 40-foot wide parcel that includes portions of the pipeline. The County purchased this property from the owner on August 10, 2010. However, that property does not include the oil water separator, the oil containment tank, most of the pipeline, nor does it provide easements on any of the adjoining properties. Accordingly, staff is seeking to exchange this property, with the reservation of an easement, for the necessary easements over the adjacent private parcels which include use of a private road that connects the system and access to the system components. Permission to access the facilities on private property has been an ongoing issue for the County.

The Thomas Fire (December 2017) and subsequent heavy rain and debris flows (January 2018, January 2023) have required numerous emergency repairs to the system. Additional maintenance and repair for the EPA-installed system is needed. This action will provide the County with those rights needed to access, monitor, operate, inspect, construct, repair, replace and maintain the systems and continue its oversight role at the Toro Canyon Oil Water Separator.

No costs other than those associated with processing and completion of this transaction are anticipated.
