**RECOMMENDATIONS:**

That the Board of Supervisors rescind location (c) of Resolution No. 75-323 which established a no parking zone on Aldebaran Avenue in the Vandenberg Village area.

**ALIGNMENT WITH BOARD STRATEGIC PLAN:**

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

**EXECUTIVE SUMMARY & DISCUSSION:**

Aldebaran Avenue is a residential collector street in the Vandenberg Village area. Buena Vista School is located on Aldebaran Avenue at Mizar Place. There is a 100 foot long no parking zone located on the south side of Aldebaran Avenue approximately 300 feet west of the entrance to the school's parking lot. This no parking zone was established in 1975 when the school buses used to drop off and pick up students there. The school does not use this location anymore and concurs that this no parking zone is no longer needed. The area is considered safe for public parking and the cost of maintaining the no parking zone exceeds the cost of removing it. (See attached vicinity map).

Based on an investigation of the site, it was determined that the no parking zone be removed. The Public Works Traffic Section has prepared the attached resolution to rescind the no parking resolution at the following location:

On the south side of Aldebaran Avenue from a point 340 feet west of the centerline of Mizar Place to a point 440 feet west of the centerline of Mizar Place.
