#### **Recommendation(s):**

That the Board of Supervisors:

#### Adopt two resolutions as follows:

#### A. ESTABLISH JOB CLASSIFICATION

Effective September 16, 2002, establish the class of Management Specialist R (Class 005021), Range 6370 (\$5,816-\$7,101 per month).

## B. ESTABLISH JOB CLASSIFICATION

Effective October 14, 2002, establish the class of Early Care & Education Program Quality Improvement Specialist (Class 002412), Range 5580 (\$3,922-\$4,788 per month).

#### **DELETE JOB CLASSIFICATION**

Effective October 14, 2002, delete the class of Early Care & Education Program Quality Improvement Coordinator (002411), Range 6020 (\$4,885-\$5,963 per month).

# Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 3. A Strong, Professionally Managed County Organization.

#### A. Executive Summary and Discussion:

This recommendation establishes a management specialist classification to oversee the general liability function of the Risk Management division of General Services. In a separate letter, General Services will request the addition of a management specialist position.

# B. Executive Summary and Discussion:

At the request of the County Administrator's Office, the Human Resources Department reviewed a small reorganization in the Early Care and Education Office. The management responsibilities assigned to the Early Care and Education Program Quality Improvement Coordinator were reassigned to the Early Care and Education Coordinator. This recommendation establishes a non-management, professional level classification of Early Care and Education Program Quality Improvement Specialist to oversee the Early Care and Education Program Quality Improvement Program. The Human Resources Department is recommending a salary of \$47,069 - \$57,461 per year (Range 5580, Step A-E) for the new classification.

This recommendation deletes the Early Care and Education Program Quality Improvement Coordinator classification since it is no longer needed.

There is no fiscal impact associated with the establishment or deletion of classifications.
