SUBJECT: Rescinding and Adopting Time Limit Parking and Parking Restrictions in the Third and Fourth Supervisorial District

Recommended Actions:

That the Board of Supervisors:

- a) Adopt the attached Resolution to rescind parking restrictions on Blosser Road in the Orcutt area of the Fourth Supervisorial District;
- b) Adopt the attached Resolution to establish time limit parking on Helena Street in Los Alamos area of the Third Supervisorial District and parking restrictions on Blosser Road in the Orcutt area of the Fourth Supervisorial District; and
- c) Find that the proposed actions are for the operation and maintenance of an existing public facility, involving negligible, or no expansion of use beyond that which presently exists, that the proposed action is therefore exempt from California Environmental Quality Act pursuant to 14 CCR 15301(c), and approve and direct staff to file the attached Notice of Exemption on that basis.

Summary Text:

This item is on the agenda to rescind existing parking restrictions and establish new time limit parking and parking restrictions on Helena Street and Blosser Road in the Third and Fourth Supervisorial District.

Proposed Parking Restrictions

Pursuant to County Code 23-11 and California Vehicle Code Sections 22507 the Board of Supervisors, by Resolution may regulate vehicle parking on certain streets or highways, or portions thereof, during all or certain hours of the day.

- **Helena Street – Third Supervisorial District**

Public Works recommends that your Board adopt the proposed 15-minute angle parking zone on Helena Street in the Los Alamos Community (Vicinity Map #1). A request for time limit parking in front of the Los Alamos Post Office was received by Public Works. There is no postal delivery service in Los Alamos and all residents in the area receive and send their mail through this Post Office. During busy days parking availability is very limited in Los Alamos which prevents residents' access to the Post Office. Public Works reviewed the location and recommends the addition of three 15-minute parking stalls to provide short term parking in front of the Post Office.

- **Blosser Road – Fourth Supervisorial District**

Public Works recommends that your Board rescind the existing parking restrictions on the east side of Blosser Road intersecting Terrazzo Way (Vicinity Map #2), and adopt the proposed parking restrictions on both sides of Blosser Road between Union Valley Parkway and Clark Avenue in the Fourth Supervisorial District (Vicinity Maps #3-6). Blosser Road is a minor arterial road with fronting and non-fronting residential houses on both sides of the road, located in the unincorporated area of Orcutt. The existing speed limit on Blosser Road is 45 mph. A request was received by Public Works to restrict parking on Blosser Road to improve line of sight for vehicles making a left or right turn at intersections on Blosser Road. Public Works reviewed the request and determined multiple no stopping, standing, or parking zones should be established along the west side of Blosser Road to ensure adequate line of sight at intersections (Vicinity Maps #4-6). Furthermore, Public Works determined that a no stopping, standing, or parking zone should be established along the entire east side of Blosser Road (Vicinity Map #3).

The Public Works Department prepared the attached Resolutions to rescind and adopt the various traffic controls at the following locations:

THIRD DISTRICT – Unincorporated Area of Los Alamos

ADOPT

15 Minute Angle Parking Zone (9 AM to 6 PM daily)

- On the west side of Helena Street from 39 feet north of the centerline of Bell Street to 70 feet north of the centerline of Bell Street.

FOURTH DISTRICT – Unincorporated Area of Orcutt

RESCIND

No Standing, Stopping, or Parking Zone:

- On the east side of Blosser Road from a point 198 feet north of the centerline of Terrazzo Way to a point 316 feet south of the centerline of Terrazzo Way.

ADOPT

No Standing, Stopping, or Parking Zone:

- On the east side of Blosser Road from the centerline of Union Valley Parkway to the centerline of Clark Avenue.
- On the west side of Blosser Road from 190 feet north of the centerline of Foxenwood Drive to 161 feet south of the centerline of Foxenwood Drive.
- On the west side of Blosser Road from 190 feet north of the centerline of Rick Road to 128 feet south of the centerline of Rick Road.
- On the west side of Blosser Road from 190 feet north of the centerline of Solomon Road to 146 feet south of the centerline of Solomon Road.

Background:

Intersection controls and parking restrictions are established based on safety, necessity, and community benefit. Public Works weighs all of these factors and presents any recommended changes to your Board for approval. These parking restrictions may include, but are not limited to “No Stopping, Standing, or Parking”, “Time Limited” parking, “Loading” zones, “Vehicle Height Restricted” parking, “Angle” parking, “Handicapped” parking, or any combination of restrictions.

Public Works has surveyed the proposed traffic control locations described in this Board Letter, and found it to be in the best interest of the communities and the traveling public to install the proposed traffic controls. Public Works recommends your Board’s approval of the attached Resolutions to implement these traffic controls. The proposed actions are for the operation and maintenance of an existing public facility, involving negligible, or no expansion of use beyond that which presently exists, and are therefore exempt from California Environmental Quality Act pursuant to 14 CCR 15301.
