## **Executive Summary and Discussion:**

Michael Stanton, the Surveyor of Tract No. 14,499 located east of Harris Grade Road, 0.3 miles north of Highway 1 and Purisima Road, in the northern Lompoc area, Fourth Supervisorial District, has informed the County Surveyor's Office that he will be unable to have all of the property monuments in place at the time the map is recorded. The monuments are to be installed to meet the requirements of Section 66496 of the State Subdivision Map Act and Section 21-16 of the County Code Chapter 21 Subdivision Regulations. The County Surveyor recommends that the subdivider be required to provide surety in the form of a certified check to guarantee installation of monuments.
