Justification: Roads Capital Equipment was budgeted and ordered in FY 22-23 and FY 23-24. Due to each order's technical specifications and supply chain impacts, equipment delivery was delayed to the current fiscal year. This budget revision increases appropriation for capital equipment ordered in prior years but delivered in the current year so that existing year equipment can be purchased. Equipment is funded with normal operating revenues.

Title: Increase Appropriations in the Public Works Funds 1930, 1931 and 1933

Budget Action: ncr approp of \$6M in PW Fund 1930 for S&S (\$893K), Cap Assets (\$1.8M), Oth Fin Uses (\$2.7M) funded by the release from RE and an increase to RE (\$580K) funded by an op transfer from PW Fund 1933. Incr approp of \$2.7M in PW TRRP Capital Fund 1931 for Capital Assets funded by an op transfer from PW Fund 1930. Incr approp of \$580K in PW Insurance Proceeds Fund 1933 for Oth Fin Uses funded by release of Restricted Purpose of Fund Balance.

Justification: In the PW RRWM Fund 1930, this budget revision is necessary to increase appropriations to complete capital projects, which were largely started in fiscal year 2024/25 and carried over to this fiscal year. This budget revision also decreases appropriations for projects budgeted in 2025/24, but will be moved to a later fiscal year.

In the PW TRRP Capital Fund 1931, this budget revision increases appropriations in Capital Assets largely funded by an operating transfer from Fund 1930. This is necessary to upgrade the MRF's equipment to capture small but valuable non-ferrous/CRV that currently can fall through the 2.5" starscreen. This would capture more CRV aluminum from both MSW organic fines as well as the Single Stream mixed glass leaving the facility.

In the PW Insurance Proceeds Fund 1933, this budget revision increases appropriations in Other Financing Uses to enable us to transfer the remaining

Title: County Health: Increase Restricted Fund Balance for unanticipated Opioid Settlements

Budget Action: Increase Appropriations of \$2.6M in the County Health Department Opioid Settlement Fund for Changes to Restricted Fund Balance funded by unanticipated revenue from interest earned (195K) and Opioid Settlements (\$2.4M) in FY 25-26.

Justification: This budget revision increases appropriations for Restricted Fund Balance funded by unanticipated revenue from interest earned and Opioid Settlements.

On June 18th, 2024, the Board of Supervisors authorized the County Health Department to manage the Opioid Settlement Funds. The Opioid Settlements are the result of County-initiated litigation against distributors and manufacturers of prescription opioids. The Opioid Settlement Funds must be expended on approved opioid abatement activities as set forth in the various settlement agreements and bankruptcy plans.
