Recommended Actions:

That the Board of Supervisors execute an agreement with the City of Santa Barbara, for the period of July 1, 2008 through June 30, 2009, for implementation of the Art in Civic Culture grants program, Community Events and Festivals grant funding, Organizational Development grants, and staffing costs, in the amount of. \$530,047.

Summary Text:

The County of Santa Barbara is required to enter into an agreement each year with the City of Santa Barbara for the provision of various arts programs, which are administered by the County Arts Commission. This successful partnership, which has existed for the past 24 years, enables the City and the County working together to deliver high quality art and cultural services to the community.

The attached agreement, upon execution by the Board, will implement the Art in Civic Culture grants program, Community Events and Festivals grant funding, Organizational Development grants, and Arts Commission staffing costs for FY 2008-09, in the total amount of \$530,047.

Background:

This is the 25th consecutive year of the County's contractual arrangement with the City of Santa Barbara to provide funding for cooperative programs administered by the County Arts Commission. This annual agreement enables the City and the County working together as partners to deliver high quality art and cultural services to the community.

The City's contribution continues to leverage State and private funding that provides additional services to residents and visitors. Funding is provided for areas of service and programs outlined in the contract.

Service elements include providing administrative resources and staff support for City arts committees, and the provision of technical assistance and training to artists, cultural organizations, and City agencies. Program elements include regranting of funds through the Community Art Program, the Events and Festivals Community Promotion Program, the Organizational Development Program, and the Cultural District Development Program.

The total amount of the grant agreement is \$530,047 and covers the period of July 1, 2008 through June 30, 2009.

There is no impact on the County's General Fund Contribution to the Arts Commission as a result of execution of this grant agreement. Revenue received as a result of this agreement, in the amount of \$530,047, will initially be deposited into the County Arts Trust Fund (#1001) and transferred to the Arts Commission's General Fund budget to cover actual program expenses. The revenue and expenditures associated with this grant have been included in the Arts Commission's adopted FY 2008-09 budget.
