

**FOURTH AMENDMENT FOR FY 2009-10 TO THE
ANIMAL CONTROL SERVICES AGREEMENT
BETWEEN THE COUNTY OF SANTA BARBARA
AND THE CITY OF SOLVANG FOR THE
REGULATION, CONTROL, AND ENFORCEMENT
OF ANIMAL CONTROL ORDINANCES WITHIN
THE CITY OF SOLVANG**

THIS IS THE FOURTH AMENDMENT TO THE AGREEMENT (hereafter **Amendment Four**) to the Agreement for Animal Control Services, July 1, 2005, (hereafter **Contract**), made by and between the **County of Santa Barbara**, a political subdivision of the State of California (hereafter **County**), and **City of Solvang** (hereafter **City**).

WHEREAS, the parties desire to amend the Contract to extend the term of the Contract and to adjust the compensation payable to County for services performed under the Contract; and

WHEREAS, this Amendment Four incorporates the terms and conditions set forth in the Contract and the First, Second and Third Amendments, except as modified by this Amendment Four.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, **County** and **City** enter into this Amendment Four on July 1, 2009, and hereby agree to amend the Contract as follows:

Section 1:

Paragraph III: Annual Fee to City is amended to read in its entirety:

Paragraph III: ANNUAL FEE TO CITY

City shall pay to the **County** no more than ~~\$32,640~~ **\$33,886** for those services set forth in this Agreement, which have been rendered by the **County** between July 1, ~~2008~~ **2009** through June 30, ~~2009~~ **2010** pursuant to this Agreement. Payment for said services rendered in the ~~2008-2009~~ **2009-10** fiscal year is due and payable upon receipt of invoice by **City** and execution of Agreement by **City** and represents a percentage of the total operating costs for services rendered to the **City** of Solvang from the **County** operated shelter in Lompoc.

Section 2:

Paragraph IX. Term of Agreement is amended to read in its entirety:

Paragraph IX. TERM OF AGREEMENT

The term of this Agreement shall be effective on July 1, ~~2008~~ **2009** and end on June 30, ~~2009~~ **2010**. The **County** shall notify the **City** prior to the end of the Agreement term of their intent to negotiate in good faith to reach agreement prior to the end of the Agreement term.

Section 3: Relationship of Amendment(s) to Original Contract

All the provisions of the Contract shall continue in effect except as modified by this Amendment Four.

Section 4:

In the event of any conflict or inconsistency between the provisions of this Amendment Four and the original Contract, including any amendments thereto, the provisions of this Amendment Four shall control in all respects.
