

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE
COUNTY OF SANTA BARBARA
STATE OF CALIFORNIA

IN THE MATTER OF ADOPTING A) RESOLUTION NO. 19-28
RESOLUTION TO INCREASE)
THE LIVE SCAN / INK PRINT FINGERPRINTING FEE)
FROM \$7.00 to \$24.00)

WHEREAS, the Board of Supervisors of the County of Santa Barbara has determined that the users of the Live Scan / Ink Print fingerprinting service should be charged a fee to cover the cost for providing the service; and

WHEREAS, the Santa Barbara County Sheriff's Office has conducted an analysis of the costs incurred to provide the service, and revenues produced by those paying the fee for the service; and

WHEREAS, the Board of Supervisors of the County of Santa Barbara has duly noticed and conducted a public hearing on January 29, 2019, at which time the public was invited to make oral and written presentations as part of the regularly scheduled Board of Supervisor meeting prior to the adoption of this resolution; and


WHEREAS, the establishment of fees for administrative services is statutory and categorically exempt from the requirements of the California Environmental Quality Act since setting these fees fits within the statutory exemptions for public agency decisions involving rates, tolls or other charges pursuant to Public Resources Code Section 21080(b)(8) and Section 15273 of the California Environmental Quality Act Guidelines.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Santa Barbara as follows:

1. This Board finds that each of the above recitals is true and that it has jurisdiction to adopt this Resolution in accordance with County Ordinance 3409 and Section 2.10.1 of the Santa Barbara County Code.
2. That the Live Scan / Ink Print fingerprinting fee increase to \$24.00 is hereby adopted.
3. That the \$24.00 fee will become effective upon adoption of this Resolution.
