

Resolution of Removal/Addition of County Roads.

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA

**WHEREAS**, Streets and Highways Code § 941 requires the Board of Supervisors by proper order to cause highways which are necessary to public convenience to be added to the County Maintained Road System; and

**WHEREAS**, the Board of Supervisors has determined that the roads in Table 1 below are necessary to public convenience and should be accepted into the Santa Barbara County Maintained Road System;

**WHEREAS**, Streets and Highways Code § 954.5 requires the Board of Supervisors by proper order to cause highways which are not necessary to public convenience to be removed from the County Maintained Road System; and

**WHEREAS**, the Board of Supervisors has determined that the road in Table 2 below does not provide primary access to the adjacent properties and is therefore not necessary to public convenience and should be removed from the County Maintained Road System;
