RECOMMENDATION

That the Board of Supervisors adopt a resolution establishing (2-way) Stop Controls in the Vandenberg Village Area (See listing of roads below).

ALIGNMENT WITH BOARD STRATEGIC PLAN

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure and Goal #5: Maintain and enhance the quality of life for all residents.

EXECUTIVE SUMMARY AND DISCUSSION

A request was received to install stop signs on Auriga Avenue at Vanguard Drive. An investigation was performed at this intersection to see if stop signs are warranted. The results of this investigation determined that sight distance is restricted on the northeast corner of this intersection. It was also determined that several other intersections (Auriga Avenue at Arcturas Avenue, Falcon Dr. at Vanguard Dr., Falcon Dr. at Rigel Rd. and Titan Avenue at Vanguard Dr.) encountered the same types of sight distance restrictions. Based on our investigation, it was determined that 2-way stops at these locations would be appropriate. The Public Works, Traffic Section has prepared the attached resolution to establish a 2-way stop control at the following locations:

- Auriga Avenue at its intersection with Arcturas Avenue.
- Auriga Avenue at its intersection with Vanguard Drive.
- Falcon Drive at its intersection with Vanguard Drive
- Falcon Drive at its intersection with Rigel Road
- Titan Avenue at its intersection with Vanguard Drive
