Justification:

The cost to purchase the new UPS system provided by Eaton Corporation through Ram-Tek is \$28,320.00. As this cost exceeds Purchasing's authority to issue a purchase order without completing a bid process, the Sheriff's Office requests a competitive bid waiver so we may take advantage of the existing Federal contract pricing. This will also allow the Department to utilize a vendor that has extensive knowledge and experience with the Dispatch Center power infrastructure, a critical component of this vital public service. Installation of the UPS will cost \$27,149.00. The total cost of the project, therefore, is \$55,469.00.

Balance in the State Forfeiture Penalty Fund Balance (Project 2084) is currently \$390,153.
