That the Board of Supervisors set a hearing for May 6, 2008 to consider accepting the donation of a Type 3 Brush Truck from the Santa Barbara Volunteer Bucket Brigade and Direct Relief International.

Summary Text:

Supervisor Carbajal and the County Fire Department were approached by members of the Santa Barbara Volunteer Bucket Brigade, who in working in conjunction with Direct Relief International, offered to purchase and maintain a Type 3 Brush Truck for use by County Fire. Direct Relief International (a 501 C3 nonprofit organization) has negotiated a contact with a vendor to purchase the truck. The Volunteer Bucket Brigade and Direct Relief International are asking the County to accept and receive the donation of this piece of equipment.

Background:

The Fire Department has stated that they have the staff required to utilize an additional Type 3 Brush Truck and that an additional truck would be of assistance in a variety of future incidents and would have been of use in fighting the Zaca Fire last summer. The truck pumps 500 gallons of water a minute, and has 1300 feet of hose.

Performance Measure:

<u>Fiscal and Facilities Impacts:</u> Direct Relief International has negotiated a sales price of roughly \$290,000. The County Fire Department would be responsible for ongoing maintenance, and depreciation.
