SUBJECT: **Renewal of Paratransit Services Contract with Easy Lift Transportation Company for FY 2003-04. First, Second, and Third Supervisorial Districts.**

That the Board of Supervisors:

Authorize the Chair to execute the attached Agreement between the County and Easy Lift Transportation Company to provide fifty-six thousand eight hundred forty-six dollars (\$56,846) in Measure D monies for unincorporated South County paratransit services during Fiscal Year 2003/2004.

**ALIGNMENT WITH BOARD STRATEGIC PLAN:**

The recommendation is primarily aligned with Strategic Plan Goal Nos. 2 and 5: to ensure the public health and safety and provide essential infrastructure, and to maintain and enhance the quality of life for all residents.

**EXECUTIVE SUMMARY & DISCUSSION:**

In 1990, through negotiations between the County, the City of Santa Barbara and the Santa Barbara County Association of Governments, the County agreed to annually provide Measure D funding to Easy Lift Transportation Company to supplement other funding sources used by Easy Lift to provide paratransit service for mobility-impaired unincorporated South County residents. The program goals outlined in Exhibit A of the attached agreement were developed during these negotiations and have consistently been met or exceeded during the last 12 years by Easy Lift.

Execution of the attached agreement will authorize the funding for the continued provision of paratransit service (demand-responsive service for the frail elderly and disabled) by Easy Lift Transportation for FY 2003/04 as stipulated in the 5-year Measure D Local Programs Plan for the unincorporated South-County.
