- 1. Approve and authorize the Chair to execute agricultural preserve replacement contract 11AGP-00000-00013, on a single 1,917-acre parcel located approximately ¼ mile northwest of the intersection of Highway 1 and Graciosa Road, known as 7367 Graciosa Road, Santa Maria area as follows:
- 2. Execute the attached contract, included as Attachment 1 of this Board Letter, creating Agricultural Preserve, 11AGP-00000-00013; and,
- 3. Authorize recordation by the Clerk of the Board.
- 4. Find that the proposed action is an administrative activity, as described in 14 CCR 15378(b)(5), which will not result in direct or indirect physical changes in the environment and is therefore not a "project" as defined for purposes of the California Environmental Quality Act (CEQA).

Summary Text:

This parcel was originally part of Agricultural Preserve Contract 70-AP-120. New Replacement Contracts are being requested for estate planning purposes. The proposed Pyche/Righetti Agricultural Preserve Replacement Contract (11AGP-00000-00013) would be a non-prime preserve consisting of one, 1,917-acre legal parcel (APNs: 101-020-069 and 113-280-009), located approximately ¼ mile northwest of the intersection of Highway 1 and Graciosa Road, known as 7367 Graciosa Road, Santa Maria area, Third Supervisorial District (Attachment 3). Approximately 1,913 acres of the 1,917-acre parcel are used for cattle grazing, while the remaining 4-acre area contains one legal-nonconforming barn, oil wells, troughs, cisterns and ranch roads. The parcel is currently zoned AG-II-100 under the Land Use and Development Code. On August 12, 2011 the Agricultural Preserve Advisory Committee reviewed 11AGP-00000-00013 and determined the replacement of an agricultural preserve contract is consistent with the Uniform Rules.

Background:

Government Code §51200 (known as the California Land Conservation Act of 1965 or the Williamson Act) provides that local jurisdictions may establish an agricultural preserve program having the goal of retaining land in an agricultural use. The County of Santa Barbara has adopted such a program, which is codified under the Uniform Rules for Agricultural Preserves and Farmland Security Zones. Both the County's Uniform Rules and the Government Code provide that agricultural-preserve contracts between the County and landowners are voluntary. Therefore, there are no state mandates associated with this program.

Fiscal and Facilities Impacts:

Budgeted: Yes

There are no fees associated with creation of agricultural-preserve contracts for applications accepted prior to May 5, 2012. The total estimated cost to process this agricultural preserve contract is approximately \$2,768.00, and is budgeted in the Permitting and Compliance Program of the Development Review North Division, as shown on page D-316 of the adopted 2011/2012 fiscal year budget.
