- c) Adopt the proposed Final Mitigated Negative Declaration (04NGD-00000-00002) pursuant to the County's California Environmental Quality Act (CEQA) guidelines as adequate environmental review for the Isla Vista Parking Program, and adopt the Mitigation Monitoring Program contained therein;
- d) Consider the introduction (First Reading) of an ordinance amending Chapter 23B of the Santa Barbara County Code regarding Residential Parking Permit Program;
- e) Consider the introduction (First Reading) of an ordinance adding Chapter 23D of the Santa Barbara County Code regarding Parking Meters;
- f) Authorize the Public Works Department to proceed with right-of-way negotiations with adjacent property owners if necessary;
- g) Authorize the Director of Public Works to advertise for construction bids for the project;
- h) Approve a waiver of competitive bids authorizing the Director of Public Works to negotiate and execute a sole source contract with AutoVu Technologies (not a local vendor) for an innovative parking enforcement license plate recognition system;
- i) Set a hearing for June 1, 2004 to consider adoption (Second Reading) of an ordinance amending Chapter 23B regarding Residential Parking Permit Program and an ordinance amending Chapter 23 regarding Parking Meters;
- j) Set a hearing for June 1, 2004 to consider adoption (Second Reading) of an ordinance adding Chapter 23D of the Santa Barbara County Code regarding Parking Meters;
- k) Direct the Public Works Department to process budget revisions transferring funds totaling \$165,000 from the General Fund Designations to the County Road Fund to fund costs associated with planning and implementation of the IV Parking Program.
