SUBJECT: Contractor on Payroll - Alcohol, Drug & Mental Health Services

Recommendation(s):

That the Board of Supervisors:

- A. Approve and execute a payroll contract for psychiatric nurse services with Diane Peterson, R.N., for the contract period of August 4, 2003 through February 22, 2004, and a maximum County cost of \$39,029.
- B. Authorize the Director of Alcohol, Drug & Mental Health Services (ADMHS) to approve amendments to the proposed contract, providing that any such amendments do not exceed ten percent (10%) of the total contract value.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit.

Executive Summary and Discussion:

In July 2001, your Board approved the acceptance of the California Supportive Housing Initiative Act (SHIA) grant award to ADMHS from the State Department of Mental Health (DMH). The SHIA grant was established to provide funding for two Intensive Case Management and Housing Support Project teams, one in North County and one in South County, to assist County clients with serious mental illness, who are at risk of housing instability, to obtain and maintain permanent, stable, affordable housing in the community. This is accomplished through a unique collaboration between public and private organizations. ADMHS will serve as the lead agency in partnership with The Mental Health Association in Santa Barbara County, Sanctuary Psychiatric Center, Transitions Mental Health Association, and Work Training Programs, Inc.

The grant required two positions of psychiatric technician to assist and support the project teams with screening and case management of the clients. In addition, these positions will provide assistance with improvement in functioning and well being of clients. ADMHS has selected Ms. Peterson, a registered nurse with the necessary psychiatric experience, to fill one of the positions as a Contractor-On-Payroll. Ms. Peterson will work with the South County team at the Santa Barbara Mission St. office.

Mandates and Service Levels:

Alcohol, Drug & Mental Health Services are mandated by Welfare and Institutions code, Section 5600.

Fiscal and Facilities Impacts:

The proposed action has no impact on facilities. There is no requirement for General Fund dollars.

The proposed contract allows for Ms. Peterson to provide up to 1,044 hours of service at a rate of \$27.95 per hour and 541 hours of On-Call Duty at a rate of \$3.00 per hour in FY 03-04, which includes \$1,355 for Medical Benefits Allowance. As Ms. Peterson is a .9 FTE contractor on payroll she is also eligible to receive benefits commensurate with that status, such as paid leave and retirement benefits, the cost of which is not included in her hourly rate. Therefore, while the actual contract maximum value is \$32,155, the action requested is for the maximum County cost, which includes the county-incurred cost for benefits of \$6,874. The County maximum cost is \$39,029. This contract is fully funded by the SHIA Grant. The revenue is included in the Adopted Budget FY 03/04—Federal and State Revenue, page D-130. The expenditure is allocated in the Operating Expenditures – Regular Salaries, page D-130. Depending on the fiscal situation in the department at the conclusion of the Grant, June 30, 2004, there will be a termination or reassignment of this position.
