SUBJECT: Construction of Concrete Sidewalk and Roadway Improvements at Various Locations in Santa Barbara County, Safe Route To School (SR2S) Program, Santa Barbara County Project No. 862246, in the 3rd, 4th and 5th Supervisorial Districts

Recommendation(s):

That the Board of Supervisors:

- A. Accept Notice of Completion for work performed by the Contractor, G. Sosa Construction Co., Inc. (not a local Vendor), 680 Woodland Drive, Los Osos, California 93402 and authorize Clerk to record.
- B. Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, G. Sosa Construction Company, Inc., in the amount of \$327,826.40.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project consisted of widening existing roadways, construction of concrete curb, gutter and sidewalks, improvements to drainage systems and installation of flashing beacons in various school zones. Approximately 1330 linear feet of sidewalk, 1600 linear feet of curb and gutter, and 10 curb ramps were constructed. This project also included widening and resurfacing 0.48 lane miles of County maintained roadway. The result of this project is safer access to 5 schools within the County. The name and location of the schools are the following; Patterson School is located on the south side of Patterson Road in the community of Orcutt, Nightingale School is located on the north side of Winter Road in the community of Orcutt, Orcutt Junior High and May Grisham School are located on the south side of Pinal Avenue in the community of Orcutt, Benjamin Foxen School is located on the west side of Foxen Canyon Road in the community of Sisquoc, and Santa Ynez Valley Christian Academy is located at the southwest corner of State Highway 246 and Refugio Road in the community of Santa Ynez.

Your Board in the FY 2002/2003 Capital Improvement Plan approved this project.

The contract was accepted on November 7, 2003, by the Director of Public Works as complete.

The project was completed on time and under the budgeted contract amount.



Mandates and Service Levels:

No change in program or service level.

Fiscal and Facilities Impacts:

The funding for this project was 90% provided by Safe Route To School Grant, and the remaining 10% was funded half by Measure D and half by Orcutt Transportation Improvement Plan. Funds have been budgeted in Fund 0015, Program 2900, Org. Unit 0002, Department 054 and Account 7511.
