Recommended Actions:

That the Board of Supervisors adopt the attached side letter agreement reached with the Santa Barbara County Fire Fighters Local 2046 for wage concessions and a one-year contract extension.

Summary Text:

The recommended action defers five previously-adopted wage increases for one year each and extends the Memorandum of Understanding (MOU) with the Santa Barbara County Fire Fighters Local 2046 (Local 2046) for one year.

Background:

Local 2046 currently represents approximately 194 employees in the Fire Department. On March 17, 2009, the Board of Supervisors approved an MOU with Local 2046 for a contract term from March 9, 2009 to March 13, 2013 which included the following wage increases:

- 2.5% effective December 27, 2010
- 2.5% effective March 7, 2011
- 3% effective September 15, 2011
- 3% effective March 5, 2012
- 3% effective September 13, 2012

On June 7, 2010, the Board adopted a wage concession agreement with Local 2046 delaying each of these increases for approximately six months. The recommended action further delays each of these increases by approximately twelve months and extends the MOU for one year with a contract expiration date of March 2, 2014 per the attached side letter agreement.

Fiscal Analysis:

The recommended action will result in estimated one-time savings of approximately \$1,484,503 in Fiscal Year 2011-2012 and approximately \$3,967,404 over the term of the contract as illustrated in the table below:

Attachment A: Side Letter Agreement

**Side Letter of Agreement
Fire Fighters Local 2046 and the County of Santa Barbara**

The parties agree that:

The Memorandum of Understanding between the parties covering the period from March 9, 2009 to March 3, 2013 shall be extended for one year, through March 2, 2014.

In addition, the parties agree that all current increases will be deferred for one year from the currently scheduled dates and will become effective at the beginning of the pay period that implements a 26 pay period delay from the current effective date. Specifically:

The negotiated salary increase of 2.5% scheduled to be received June 27, 2011 shall be deferred and shall be received June 25, 2012.


The negotiated salary increase of 2.5% scheduled to be received September 5, 2011 shall be deferred and shall be received September 3, 2012.

The negotiated salary increase of 3% scheduled to be received March 5, 2012 shall be deferred and shall be received March 4, 2013.


The negotiated salary increase of 3% scheduled to be received September 3, 2012 shall be deferred and shall be received September 2, 2013.

The negotiated salary increase of 3% scheduled to be received February 18, 2013 shall be deferred and shall be received February 17, 2014.

The parties agree that all savings realized as part of this agreement shall remain in the Fire Department.
