On November 7, 2023, the Santa Barbara County Board of Supervisors (Board) will conduct a public hearing to consider the adoption of amendments to the County Land Use and Development Code (LUDC), Montecito Land Use and Development Code (MLUDC), and Coastal Zoning Ordinance (CZO) to: revise the permitting and development standards for ADUs, eliminate the Shopping Center (SC) zone district and rezone those properties to Retail Commercial (C-2), and process other minor ordinance amendments that correct and clarify existing text provisions.
