WHEREAS, California Vehicle Code Section 22507 and the Code of Santa Barbara County, California, Section 23-11, authorize the Board of Supervisors of the County, to establish parking restrictions on portions of roads and highways under its jurisdiction; and

WHEREAS, it is in the best interest of public safety that certain portions of County highways in Santa Barbara County are designated as no stopping, standing, or parking zones, in accordance with said Sections;

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County is hereby designated as a no stopping, standing, or parking zone or no stopping, standing, or parking zone during certain hours and that the Director of Public Works of the County of Santa Barbara is hereby authorized and directed to install and maintain appropriate pavement markings and signs at the following locations:

## No Stopping, Standing, or Parking Zone

 On the west side of Walnut Lane from the centerline of Oak View Lane to 110 feet south of the centerline of Oak View Lane.

## No Stopping, Standing, or Parking Zone (Sunset to 8 a.m.)

- On the west side of Auto Park Drive from the centerline of Goodwin Road to the centerline of Skyway Drive
- On the east side of Auto Park Drive from the centerline of Goodwin Road to 125 feet south of the centerline of Mercury Drive.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to install appropriate markings and/or signs at said locations as time and resources permit.
