RECOMMENDATIONS

That the Board of Supervisors adopt a resolution establishing a Disabled Accessible Parking Zone on Orcutt Road in the Orcutt area.

ALIGNMENT WITH BOARD STRATEGIC PLAN

The recommendation is primarily aligned with: Goal #2: Ensure the public health and safety and provide essential infrastructure and Goal #5: Maintain and enhance the quality of life for all residents.

EXECUTIVE SUMMARY & DISCUSSION

This section of Orcutt Road runs between Waller Lane and Goodwin Road and provides an entrance into the east side of Waller Park. The road consists of two travel lanes with on-street angle parking on the west side of the street. The Parks Department has requested that a disabled accessible parking zone be established on Orcutt Road in front of the park. Based on a field investigation, it was determined by the Public Works Department that a disabled accessible parking zone be established at the following location:

- On the west side of Orcutt Road from a point 1,054 feet south of the centerline of Waller Lane to a point 1,079 feet south of the centerline of Waller Lane.

In accordance with the American Disabilities Act (ADA), the disabled accessible parking zone will consist of a parking stall (min. 9' 0" wide) and a loading and unloading zone (min. 5' 0" wide) located on the passenger side of the vehicle for persons with disabilities.
