WHEREAS, Diana Ornelas, Director of the Carpinteria Boys & Girls Club, has demonstrated exceptional leadership through her work with the United Boys & Girls Clubs of Santa Barbara County by fostering a culture of safety, stability, and belonging for youth and families, including coordinating safe transportation to school, arranging grocery deliveries, and partnering with community nonprofits to build a network of support for families facing hardship; and

WHEREAS, her advocacy has helped establish the Carpinteria Boys & Girls Club as a trusted safe haven and a dependable source of affordable childcare, directly addressing one of the most pressing concerns facing women in Santa Barbara County: access to reliable, safe, and affordable childcare that enables women to remain in the workforce, pursue education, and support their families; and

WHEREAS, Diana has strengthened program quality and safety throughout Santa Barbara County by expanding Continuous Quality Improvement practices, mentoring club directors through site observations, and leading safety and trauma-informed care workshops that equip youth-serving professionals with the tools needed to support children experiencing adversity; and

WHEREAS, she is a Tier 3 National Trainer for Boys & Girls Clubs of America, Diana provides specialized training in Trauma-Informed Practices and Child Abuse Prevention, delivers workshops across the county and region, and contributes to national cohorts focused on youth impact, workforce readiness, and emerging leadership, helping ensure young people are prepared for healthy, successful futures; and

WHEREAS, Diana's commitment to equity and community service extends beyond her professional role through national leadership with the Latinos Unidos Movement Resource Group, advocacy for Spanish-language access to resources for families and staff, participation in initiatives that foster belonging and leadership development, and volunteer service through Rotary building homes in Mexico and supporting orphanages, reflecting her deep dedication to strengthening families and uplifting communities;

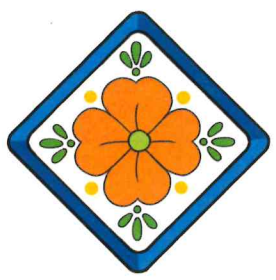

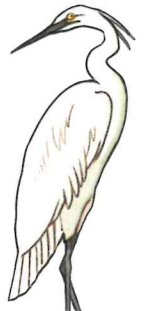

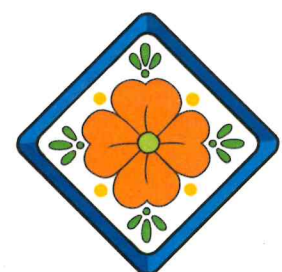
