ELECTED OFFICIALS OF THE COUNTY OF

WHEREAS, on December 6, 2016, Resolution No. 16-282 established biweekly salaries for Elected Department Heads, including a provision that “future compensation pool increases granted by the Board to Appointed Department Heads shall apply to Elected Department Heads as a flat percentage rate increase”; and

WHEREAS, Resolution No. 16-282 included specific biweekly rates as a result of increases projected out to July 2, 2018; and

WHEREAS, the specific biweekly rates established in Resolution No. 16-282 are now obsolete because a unit cash allowance previously paid to Elected Department Heads was subsequently incorporated into base wages, effective April 23, 2018; and

WHEREAS, this Board of Supervisors finds that there is good cause to continue the provision to apply compensation pool increases granted by the Board to Appointed Department Heads to the actual current salaries of Elected Department Heads as a flat percentage rate increase;

NOW, THEREFORE, IT IS HEREBY RESOLVED, as follows:

1. The biweekly salaries for elected department heads shall be as follows effective 7/2/2018:

<u>OFFICE</u>	<u>BIWEEKLY RATE</u>
Auditor-Controller	\$8,157.60
County Clerk-Recorder-Assessor	\$8,073.55
District Attorney	\$8,811.86
Sheriff-Coroner	\$8,631.40
Treasurer-Tax Collector-PA	\$8,073.55

2. Future compensation pool increases granted by the Board of Supervisors for appointed department heads shall apply to elected department heads as a flat percentage rate increase.
3. Human Resources shall conduct salary surveys in the second and fourth year of each term of office and submit to the Board of Supervisors any recommendations for adjustments based on market data.
