A. Approve the Notice of Exemption pursuant to the California Environmental Quality Act (CEQA) guidelines regarding the proposed acceptance of an Easement Deed from Mr. Ronald Mees to the County of Santa Barbara;

B. Accept a <u>Permanent Easement</u> from Mr. Ronald Mees, owner of Santa Barbara County Assessor parcel number 111-110-008, by authorizing the Clerk of the Board to sign the Certificate of Acceptance attached to the Permanent Easement deed. (Clerk, Four-fifths vote required). The easement encumbers a portion of Mr. Mees property at 3205 Orcutt Frontage Road, near the City of Santa Maria (Fourth District).
