NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following Resolutions establishing no parking zones on portions of Camino Corto, be rescinded in their entirety at the hereinafter designated locations:

- Resolution No. 80-83
 - On both sides of Camino Corto between the centerline of El
 Colegio and a point 80 feet south of the centerline of El Colegio.
- Resolution No. 87-478(2)
 - On the west side of Camino Corto between a point 148 feet south of the El Colegio centerline and a point 182 feet south of the El Colegio centerline.
- Resolution No. 87-520(b)
 - On the west side of Camino Corto between a point 50 feet south of the centerline of El Colegio and a point 300 feet south of the centerline of El Colegio.
- Resolution No. 87-520(c)
 - On the east side of Camino Corto between a point 80 feet south of the centerline of El Colegio and a point 250 feet south of the centerline of El Colegio.
- Resolution No. 94-452

On both sides of Camino Corto between the centerline of Abrego Road and the centerline of EL Colegio Road.

IT IS FURTHER RESOLVED, that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to designate said locations with appropriate markings and/or signposts as time and resources permit.
