Justification: This budget revision recognizes the insurance proceeds from the Alisal Fire event. PW RRWM received \$5M in insurance proceeds in FY 2021/22. Insurance

confirmed additional disbursement of \$3.1M will be made in FY 2022/23, for repairs to the MRF biofilter damaged during the Alisal Fire. The initial disbursement of \$5M was deposited in the General Fund, where interest was earned. Although the \$5M was transferred to the PW RRWM Fund, interest

earnings of \$5,100 will be transferred to the Public Works Funds upon approval of this budget revision.

The Alisal Fire damaged the MRF biofilter which was funded by 2018 COPs. To comply with bond covenants, PW RRWM is required to establish a new Special Revenue Fund called Insurance Proceeds Fund to hold insurance proceeds related to the 2018 Project until PW RRWM notifies the Trustee its plans to repair or replace the 2018 Project in whole or in part. As such, PW RRWM Fund 1933 was established and this budget revision will transfer the insurance proceeds of \$3.3M for the rebuild of the biofilter. In addition, interest earnings from the General Fund of approximately \$1,000, will also be transferred to PW RRWM Fund 1933.

Additional repairs relating to the Alisal Fire will be funded by the release of Retained Earnings in PW RRWM Fund 1930 from insurance proceeds received last fiscal year. The funding includes repairs to the Tajiquas Landfill and a transfer to the TRRP Capital Fund 1931 for a new blower at the ReSource Center.

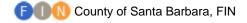
