Establish appropriations of \$229,800 in Public Defender General Fund (\$85,200 for Salaries and Benefits and \$48,200 for Services and Supplies and \$96,400 for

Intrafund Transfer (+)), funded by unanticipated Byrne JAG grant revenue. Establish appropriations of \$96,400 in Probation Department General Fund for Services and

Supplies funded by Intrafund Transfer (-) from the Public Defender General Fund.

The Edward Byrne Memorial Justice Assistance Grant (JAG), administered by the Board of State and Community Corrections (BSCC), is a vital federal program in the Justification:

United States that provides financial support to state and local governments to develop and improve public safety. The Public Defender was awarded \$715,000 over three years, to support creation of the Holistic Reentry, Early Access, and Diversion for You (READY) unit. The READY unit will facilitate assessment, connection, and reentry of individuals booked into jail, with the goal of providing an assessment of needs, connection to services, and representation at the earliest stage of a criminal case. The READY team consists of a Legal Office Professional for Public Defender, data evaluation through UCSB, and a mental health Peer Navigator for Probation. The grant's project period is between June 1, 2023 through June 30, 2026. This budget revision requests includes anticipated year 1 costs, and future years' costs will be

included in the budget development process.
