the Southeast one-quarter of the Northeast one-quarter and the East one-half of the Southeast one-quarter of said Section 10, together with,

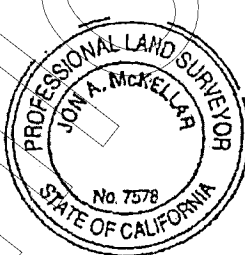

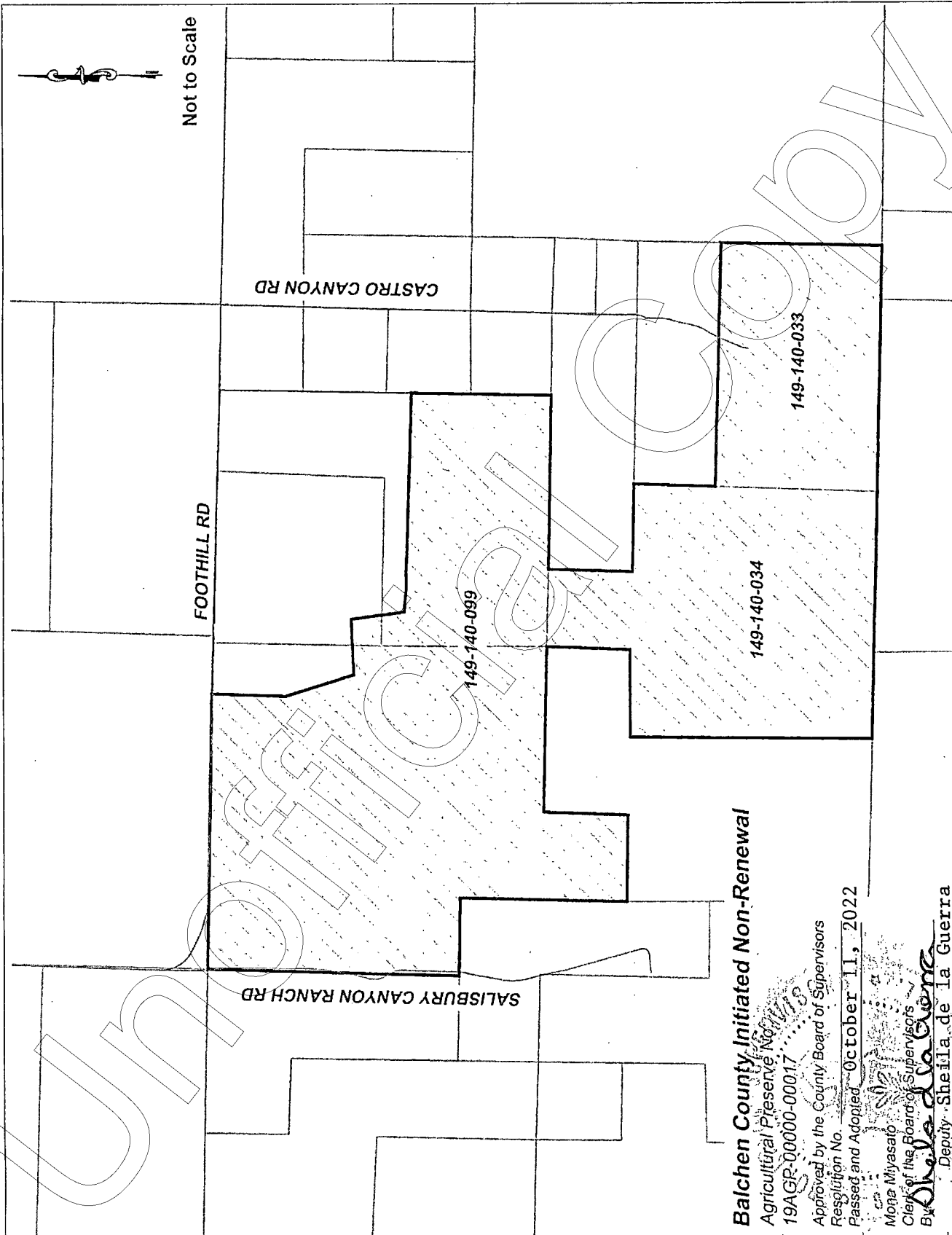
