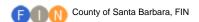

Justification: The Budget Act of 2021 (Senate Bill 129) established the Public Defense Pilot (PDP) Program. PDP Program funds must be utilized for indigent defense providers, including public defenders, alternate defenders, and other qualifying entities that provide indigent defense in criminal matters for the purposes of

workload associated with the provisions in paragraph (1) of subdivision (d) of Section 1170 of, and Sections 1170.95, 1473.7, and 3051 of the Penal Code. The grant funds may be expended through FY 2024-25. On July 18, 2023, the Board approved, ratified and authorized the Public Defender to execute the

BSSC Grant Agreements accepting \$1,122,300 grant funds (\$563,600 for Year 1 and \$558,700 for Year 2).

This budget revision reimburses General County Programs for grant-eligible program costs incurred in the prior fiscal year (FY 2022-23), including salary & benefit costs of \$317,400 and services & supplies costs of \$300. These expenditures funded 1.0 FTE Deputy Public Defender IV, 1.0 Extra-Help Department

Business Specialist (Data Analyst), and fiscal staff time.

A separate budget revision (BJE #0009119) increases appropriations for FY 2023-24 expenditures of \$558,700. The remaining grant funding will be

appropriated and spent in FY 2024-25 in accordance with the grant expenditure deadline.
