SUBJECT: BEACON Revenue Agreement for FY 24-25 to provide Legal Services

Recommended Actions:

That the Board of Supervisors:

- (a) Approve, ratify, and authorize the Chair to execute the attached revenue Agreement to provide Legal Services between the County of Santa Barbara and BEACON with a period of performance from July 1, 2024 through June 30, 2025 for a projected revenue not to exceed \$15,000; and,
- (b) Determine that the above actions are not a "Project" under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Sections 15378(b)(4) and 15378(b)(5) because the actions consist of government administrative and fiscal activities that will not result in direct or indirect physical changes in the environment.

Summary Text:

The Agreement for FY 2024-2025 will allow County Counsel's Office to continue providing BEACON legal services during the next fiscal year. (Attachment 1.)

BEACON is a public agency established under the California Joint Exercise of Powers Act and is governed by the terms of a Joint Powers Agreement and associated bylaws. (Gov. Code §§ 6500 et seq.) BEACON's purpose is to "foster greater cooperation toward the maintenance and enhancement of the beaches within the jurisdiction of BEACON Member Agencies." (Bylaws, Art. 1, § 2.) Santa Barbara County is a member agency of BEACON and provides legal services to BEACON through the Office of County Counsel. This Agreement between the County of Santa Barbara and BEACON will allow the Office of County Counsel to continue providing legal services to BEACON.

Fiscal and Facilities Impacts:

Fiscal Analysis:

The Agreement does not have any new fiscal impacts. The Office of County Counsel has been providing legal services to BEACON since its formation in 1986 and it is included within the existing budget as revenue.

Key Contract Risks:

The Agreement is considered low risk because it contains a clause permitting termination upon a 90-day notice.
