MK Elections tracked the return of undeliverable ballots and mailed replacement ballots to voters upon their request and/or the request of the organization.

MK Elections completed the ballot count at the Santa Barbara County University office in Santa Barbara, California starting at 12:30PM on October 11, 2023. During the open period of the election, the ballots were returned to a post office box in Goleta and remained in the custody of the United States Post Office until the ballot pickup. The scanning and counting processes were audited on real ballots to ensure that it was counting correctly.
