**RECOMMENDATION**

That the Board of Supervisors adopt two resolutions establishing an angle parking zone and a no parking zone on Pinal Avenue in the Orcutt Area.

**ALIGNMENT WITH BOARD STRATEGIC PLAN**

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure and Goal #5: Maintain and enhance the quality of life for all residents.

**EXECUTIVE SUMMARY AND DISCUSSION**

In May 2002, Grisham Elementary School constructed a site improvement project which added angle parking and sidewalk on the south side of Pinal Avenue fronting their school. No resolution was written for this angle parking at the time. Since then, the Public Works Traffic Section investigated the site and determined that the angle parking is appropriate at this location, with the exception of the westernmost stall. A vehicle backing out of the westernmost stall would conflict with the school crosswalk. Therefore, this westernmost stall shall not be used for parking. The Public Works, Traffic Section has prepared the attached resolutions to establish an angle parking zone and a no parking zone at the following respective locations:

**ANGLE PARKING**

- On the south side of Pinal Avenue from a point 109 feet west of the centerline of Garrett Street to a point 283 feet west of the centerline of Garrett Street.

**NO PARKING**

- On the south side of Pinal Avenue from a point 268 feet west of the centerline of Garrett Street to a point 283 feet west of the centerline of Garrett Street.
