Important to note is that my experience was with children from affluent families, this was not only because of limited resources.

I believe it is very important to recognize that the concept of parent involvement in education as we understand it in the US is not practiced in Mexico. It might even be seen as disrespect for the teacher and the school. It is our responsibility to know this and teach this paradigm to the families we serve from Mexico. I am able to bring this important cultural perspective.
