Justification: Funds were previously earmarked in the General County Programs General Fund Committed Litigation fund balance for the Cleanup and Abatement Order (CAO) No.

R3-2023-0070 issued by the Regional Water Quality Control Board - Central Coast Region for 2936 industrial Parkway, Santa Maria, CA. This budget revision is necessary to appropriate \$487,500 of the \$1,000,000 earmark for a transfer to the General Services Department General Fund FY 2025-26 Budget for processing

payments to Langan Engineering to perform the monitoring, investigation, feasibility study, and work plan services during this fiscal year.

The CAO was issued for historic discharges of pollutants near the Santa Maria Public Airport from 1964 to 1968, during which time SEMCO Twist Drill and Tool

Company, Inc. (SEMCO) operated a precision tool manufacturing business on the site.

This Board Item authorizes the General Services Director or designee to execute a First Amendment to Agreement for Services of Independent Contractor with Langan CA, Inc. between the County of Santa Barbara, the City of Santa Maria, and the Santa Maria Public Airport District, to carry out the required actions necessary to comply with Cleanup and Abatement Order No. R3-2023-0070 issued by the Regional Water Quality Control Board – Central Coast Region for 2936 Industrial Parkway, Santa
