SUBJECT: Board of Supervisors' Meeting Schedule for 2005

Recommendation(s):

That the Board of Supervisors:

Set a hearing for January 4, 2005 to consider adoption of the 2005 Board of Supervisors' schedule of meeting dates and locations.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with actions required by law or by routine business necessity.

Executive Summary and Discussion:

The Board of Supervisors holds regular meetings on the first four Tuesdays of each month except as otherwise directed by your Board; the Board does not meet on fifth Tuesdays. Attached to this Board Letter are three options for the Board to consider for the 2005 schedule of meetings dates and locations. Option 1 (Attachment A) continues the current practice of meeting once a month (on the second Tuesday) at the Betteravia Government Center in Santa Maria and the remaining three Tuesdays in Santa Barbara. Option 2 (Attachment B) reflects two meetings per month at the Betteravia Government Center in Santa Maria occurring on the second and fourth Tuesday of each month and Option 3 (Attachment C) reflects two meetings per month at the Betteravia Government Center occurring on consecutive weeks (third and fourth week of the month). Note that option three may be amended to reflect consecutive North County meetings on different weeks as directed by the Board.

The County of Santa Barbara budget hearings are conducted the second week of June. As such, in anticipation of the Fiscal Year 2005-06 Budget Hearings, the 2005 schedule does not include a regular hearing on Tuesday June 14, 2005. FY 2005-06 budget hearings will be scheduled by separate Board Letter in the spring of 2005.

In previous years, the Board of Supervisors calendar has experienced a slow period during the summer months that has resulted in the cancellation of regularly scheduled meetings and in several half-day hearings. The adopted 2004 Board of Supervisors schedule of meetings included a two week break in the summer during the last two weeks of August, including a fifth Tuesday. Similarly, the proposed 2005 schedule incorporates a two week summer break during the last two weeks of August; Tuesday, August 23, 2005 and the following week, a fifth Tuesday, August 30, 2005. Advanced knowledge of a summer recess will allow the Board and staff to efficiently schedule and set hearings for the remaining Board meetings through the summer and provide an opportunity for personal planning.

Mandates and Service Levels:

Government Code Section 25081 requires the Board of Supervisors to hold regular meetings at the County seat which is located in the City of Santa Barbara. Santa Barbara County Code Chapter 2, Article 1, Section 2-1 provides that a regular adjourned meeting may be held outside of the County seat on a regular meeting date in lieu of a regular meeting.

Fiscal and Facilities Impacts:

The cost differentials between the three options for scheduling Board meetings are considered minimal.
