Recommended Actions:

- A. Adopt the Resolution establishing the final quantities for work performed and materials supplied for the March 2011 Storm Repair Project for the Bradley Channel by the contractor Brough Construction, Inc., in the amount of \$128,093.00.
- B. Find that the proposed action does not constitute a "Project" within the meaning of CEQA, pursuant to 14 CCR 15378 (b)(4) The creation of government funding mechanisms or other government fiscal activities which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment and 14CCR 15378 (5) Organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment.

Summary Text:

On August 9, 2011, the Board entered into an agreement with Brough Construction, Inc. to construct the March 2011 Storm Repair Project for the Bradley Channel in the amount of \$122,959.00. The repairs addressed a segment of channel damaged in the 2011 winter storms. The work repaired approximately 380 feet of channel located between Jones Street and Stowell Road in the City of Santa Maria.

This project was completed at a cost of \$128,093.00. The Flood Control District has accepted the work of the contractor Brough Construction, Inc., completed on-time and per plans and specifications. On November 3, 2011, the Public Works Director signed and executed a Notice of Completion (NOC) for the project and that NOC was recorded on November 8, 2011.

Background:

The Bradley Channel is a major drainage and flood control project located in the City of Santa. The Channel is owned and operated by the Flood Control District.

On June 7, 2011 the Board of Supervisors found that the proposed concrete repair of the Bradley Channel liner is exempt under California Environmental Quality Act (CEQA) guidelines, Section 15301 (b), pertaining to the repair of the approximately 380 ft. long section between Jones St. and Stowell Road, with no associated expansion of the existing use. Staff filed the Notice of Exemption with the Clerk of the Board on May 10, 2011.
