Summary Text:

August has been celebrated as Child Support Awareness Month since President Clinton's 1995 federal proclamation. Locally, Child Support professionals will observe the month with a vigorous effort to regain contact with parents who have fallen behind on their child support payments and with public outreach to raise awareness of the Child Support Program.

Background: Almost 13,000 families are served through Santa Barbara's Child Support program. Of these, approximately one-half are entitled to regular monthly payments, and we are able to collect on 85% of those cases. For those absent parents who are not paying, there can be many reasons for the lapse. Unfortunately, the automated enforcement remedies are not programmed to consider changing circumstances. Well intentioned non-payers can become embroiled in disastrous consequences, one of those being suspension of driver licenses. During the month of August, Santa Barbara Child Support will publicize a campaign titled "Get Back on the Road" to release driver licenses. Clients who have or are in jeopardy of having their licenses suspended will be contacted regarding this program and how they can get licenses released and/or retained. In addition, Child Support is participating in some community-wide events in August, such as: a joint Family Day in the Park and Healthy Kids Day sponsored by the Santa Maria YMCA, Summer Fiesta Time sponsored by St. John Neumann Church at Oakley Park in Santa Maria, a Community and Education Fair for the Lompoc Unified School District at

the El Camino Community Center, and a presence at the Sunken Gardens during Fiesta to provide Child Support information to the public.
