Approving a Lease

**FOR OPERATION, MAINTENANCE, AND REPAIR OF THE ROCK REVENTMENT
ORGINALLY CONSTRUCTED IN 1964 AS ESTABLISHED BY SANTA BARBARA
COUNTY BOARD OF SUPERVISORS, PURSUANT TO THE ESTABLISHMENT OF
THE SANDYLAND SEAWALL MAINTENANCE DISTRICT No. 1 IN SANTA
BARBARA COUNTY**

WHEREAS, on May 11, 1964 certain upland beach areas southwest of Sandpoint Road near Carpinteria were provided an easement by the Santa Barbara County Board of Supervisors for the purpose of protecting limited areas of the shoreline from the Pacific Ocean along the Santa Barbra County shoreline; and

WHEREAS, the County of Santa Barbara constructed a rock revetment seawall within the easement for Sandyland Seawall Maintenance District No.1 pursuant to the provisions of the Improvement Act of 1911, Division 7 of the Streets and Highways Code of the State of California; and

WHEREAS, the County of Santa Barbara by agreement with Sandyland Seawall Maintenance District No.1 continues operation, maintenance, and repair of the rock revetment within the easement areas; and

WHEREAS, operation, maintenance, and repair of the rock revetment requires a Lease from the State Lands Commission.

NOW, THEREFORE, BE IT RESOLVED that the County of Santa Barbara Board of Supervisors hereby

1. Approves the Lease for operation, maintenance and repair of the existing rock revetment southwest of Sandpoint Road, near Carpinteria in Santa Barbara County; and
2. Delegates the authority to the Director of Public Works to sign and submit all documents, including, but not limited to applications and payment requests, which may be necessary.
