Recommendation:

That the Board of Supervisors authorize the issuance of a grading permit for the above referenced tract pursuant to County Code Chapter 21-8-C4, prior to recordation of the Final Map, upon approval of Planning and Development.

Executive Summary and Discussion:

The applicant has requested permission to begin grading prior to Recordation of the Final Map. County Code Chapter 21-8-C4 allows for the issuance of a grading permit prior to the recordation of a Final Tract Map provided that the grading plan is approved, grading fees and all required bonds are in place, the first plan check of the Final Map has been completed by the Office of the County Surveyor, and approval is obtained from the Board of Supervisors.

The Grading Permit will not be issued until all of the above items have been completed, and all of the normal departmental signoffs are obtained for the permit.
