WHEREAS, the Transportation Development Act (TDA), as amended (Public Utilities Code Section 99200 et seq.), provides for the allocation of funds from the Local Transportation Fund and the State Transit Assistance Fund, for use by eligible claimants for various transportation purposes; and

WHEREAS, pursuant to the provisions of the TDA, as amended, and pursuant to the applicable rules and regulations thereunder (21) Cal. Admin. Code Sections 6600 et seq.) a prospective claimant wishing to receive an allocation from the Local Transportation fund or the State Transit Assistance Fund shall file its claim with the Santa Barbara County Association of Governments.

**NOW, THEREFORE, BE IT RESOLVED,** that the <u>County Public Works</u> <u>Director</u> is authorized to execute and file an appropriate claim pursuant to applicable rules and regulations promulgated hereunder, together with all necessary supporting documents, with the Santa Barbara County Association of Governments for an allocation of TDA funds in FY <u>2009/2010</u>.

**BE IT FURTHER RESOLVED THAT** the authorized claim include \$<u>41,950</u> for SBCAG's regional transportation planning, <u>\$203,588</u> for County transit and pedestrian and bicycle facilities, <u>\$1,532,846</u> for Santa Maria, Lompoc and Santa Ynez Valley transit or paratransit purposes, and <u>\$355,207</u> for street and road purposes.

BE IT FURTHER RESOLVED THAT a copy of this resolution be transmitted to the Santa Barbara County Association of Governments in conjunction with the filing of the claim.
