Recommendation:

That the Board of Supervisors:

- A. Approve the attached <u>Notice of Exemption</u> pursuant to the California Environmental Quality Act (CEQA) guidelines.
- B. Authorize the Chair of the Board of Supervisors to execute the attached <u>Letter of Permission</u> to grant a license to the California Coastkeeper Alliance for permission to apply to the California Coastal Commission for the necessary permit for a kelp restoration project to restore the marine habitat near Carpinteria Reef. The grant of permission shall be valid for a period of three (3) years from the project's start date, estimated date of May 2003.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1.: An Efficient Government Able to Respond Effectively to the Needs of the Community and with actions required by law or by routine business necessity.

Executive Summary and Discussion:

The California Coastkeeper Alliance, through a partnership with the National Oceanic and Atmospheric Administration Fisheries' Community Based Restoration Program, launched a regional project to restore kelp forests to depleted reefs in Southern California. The Southern California Regional Kelp Restoration

Project has established kelp restoration and/or monitoring sites at Point Loma in San Diego County, Crystal Cove in Orange County, and Escondido Reef in Los Angeles County. The California Coastkeeper biologists identified an area in Santa Barbara County, Carpinteria Reef, where kelp was historically present but is now a barren reef.

The State of California in the early 1900's granted to the County of Santa Barbara the public trust responsibility/ownership of the tidelands and waters off Carpinteria. The County's responsibilities include administering the activities in these waters and therefore, a letter of permission is being requested in order to facilitate an amendment to include the Carpinteria Reef site in the California Coastal Commission Administrative Permit (No. E-01-018). A letter of support from the County of Santa Barbara granting permission to the California Coastkeeper Alliance to restore kelp at Carpinteria Reef is attached for the Chair of the Board of Supervisors to execute.

For the past several months, the California Coastkeeper Alliance have been working to obtain letters of permission, as required, from other regulatory agencies to commence restoration work at Carpinteria Reef. These letters of permission from other agencies include; U.S. Department of Transportation, United States Coast Guard; United States Department of the Interior, Fish and Wildlife Service; and the State of California Department of Fish and Game.

Mandates and Service Levels:

No change in programs or service levels.

Fiscal and Facilities Impacts:

The California Coastkeeper Alliance is a nonprofit organization and does not have a project budget that anticipated administrative cost to reimburse local public agencies for the cost of service. Therefore, the cost of Real Property services associated with this project in the amount of approximately \$800 is not reimbursable from the California Coastkeeper Alliance.

<u>California Coastkeeper Alliance – Carpinteria Reef Kelp Restoration Project</u>

In response to your fax submittal dated March 18, 2003, for kelp restoration work off Carpinteria, Santa Barbara County, the County of Santa Barbara by way of this letter grants to the California Coastkeeper Alliance permission to restore kelp at Carpinteria Reef under the following restrictions:

- 1. The California Coastkeeper Alliance obtains the necessary amendment to include the Carpinteria Reef site in your California Coastal Commission Administrative Permit (No.E-01-018). A copy of the permit shall be sent to the County General Services Department, Facilities Services Division, 1100 Anacapa Street, Courthouse Annex, Santa Barbara, California, 93101.
- 2. The California Coastkeeper Alliance obtains any and all necessary permission, permits, and other regulatory authority from the appropriate agency.
- 3. The permission granted to California Coastkeeper Alliance shall be valid for a period of three (3) years from the project's start date (estimated start date, May 2003).
- 4. The California Coastkeeper Alliance shall provide the County of Santa Barbara, through the General Services Department, with a written annual report on the restoration activities, and all CEQA documentation. Upon completion of the project, the California Coastkeeper Alliance shall provide the County with the final report.
- 5. The California Coastkeeper Alliance Carpinteria agrees that the Restoration Kelp Project on Carpinteria Reef will not interfere with any elements of the Carpinteria Salt Marsh Enhancement Project which is a project currently under environmental review at the County.
