### **Summary Text:**

The Workers' Compensation Insurance Fraud program is designed to investigate allegations of Workers' Compensation Fraud, arrest offenders, prosecute violators, and seek restitution for funds lost through fraudulent claims.

### **Background:**

Workers' Compensation Fraud is a community and statewide issue which impacts industry, employers, the medical profession, insurance companies, employees, and local businesses. There is a direct correlation between workers' compensation fraud and increases in insurance premiums. Fraud results in higher insurance premiums for all employers which, in turn, is passed on to the consumer through an increase in costs of goods and services we use every day. These factors led the Santa Barbara County District Attorney's Office to develop the Workers' Compensation Fraud Program which brings local businesses, the Department of Insurance, and the District Attorney's Office together to tackle Workers' Compensation Fraud in Santa Barbara County.

In November 2003, your Board authorized the District Attorney's Office to implement a Workers' Compensation Insurance Fraud Unit in North County. This is a collaborative effort with the North

County business community and the California Department of Insurance. CDI is financed through fees assessed by the State Insurance Commissioner as part of the workers' compensation insurance rates and has been an effective program in other California counties.) The long term goal of this initiative is to reduce workers' compensation insurance fraud in Santa Barbara County through crime prevention and deterrence, to be accomplished through a combination of community education and criminal prosecution of fraud cases.

The unit includes a .5 Prosecutor, .5 Criminal Investigator and .5 Sr. Investigative Assistant dedicated to workers' compensation insurance fraud cases. Year to date this fiscal year, 26 new merchant referrals and 29 carryover cases of suspected Worker's Compensation Fraud were reviewed and investigated by the Unit. Many of these did not result in criminal filings and were returned for further action by the Workers Compensation Appeals Board. Of the nine cases filed for criminal prosecution, five resulted in convictions that included over \$104,000 in restitution orders, with the others pending settlement. Nineteen cases will be carried forward for additional investigation next fiscal year.

### Narrative:

No facility impacts are associated with this item, as the staff is located in the North County District Attorney Office. DOI financing has increased to \$204,772, including \$3,000 in carryover funds for FY 06-07. It includes \$181,626 in salary and benefit costs, along with \$9,497 in operating costs and \$13,649 in overhead charges to sustain this program. Expenses and revenues are budgeted in the District Attorney's FY 06-07 budget, department 021, program 1010.
